I, _____, whose date of birth is _____, and who resides at _____, Colorado, hereby swear (or affirm) that I am a qualified elector of the Englewood Downtown Development Authority (“DDA”) and desire to vote at the mail ballot coordinated election of the City of Englewood on November 2, 2021, concerning the DDA, and I: **(required)**

_____ I am a resident who is a citizen of the United States, a resident of the State of Colorado, eighteen years of age or older, and whose primary dwelling place is within the boundaries of the DDA; **or**

_____ I am a landowner in fee of an undivided interest in real property or of an improvement permanently affixed to real property within the boundaries of the DDA. A “landowner in fee” includes a contract purchaser obligated to pay general taxes, an heir, and a devisee under a will admitted to probate, and does not include a contract seller of property with respect to which the contract purchaser is deemed to be the landowner in fee; **or**

_____ I am a lessee holding a leasehold interest in real property within the boundaries of the DDA. A “leasehold interest” does not include a license or a mere contract right to use real property within the DDA; **or**

_____ I am a representative of a qualified landowner or lessee which is not a natural person who has been designated by official action of the qualified landowner or lessee to cast its ballot.

NO QUALIFIED ELECTOR SHALL BE PERMITTED TO CAST MORE THAN ONE VOTE. See Section 31-25-802(9), C.R.S.

I am requesting a mail ballot for the mail ballot election to be held on November 2, 2021, because: **(check one)**

- I have not received the original ballot;
- the original ballot is defective, lost or spoiled; or
- a mail ballot will not be sent to me automatically because my voter eligibility cannot be determined by the County’s registered voter or property owner lists for this election.
